DESCRIPTION

GlueRemove™ is a safe non-flammable, water-based glue and mastic remover that effectively softens and removes most types of carpet adhesives and similar glue deposits.

APPLICATION

GlueRemove may be sprayed from a pump-up sprayer, brushed, or mopped on evenly across the surface to be treated. Apply at the rate of approximately 1 gallon to 150 ft² (13.9 m² per 3.8 L). Allow GlueRemove to stand for a minimum of 25 - 45 minutes to emulsify and soften the mastic. Once the layer is softened, just scrape it off and rinse thoroughly with water. Heavy mastic removal may require additional applications. No further treatment is necessary.

NOTE: When staining the concrete surface is desired, it is recommended to use SCR to ensure all residual material in the pours of the concrete are removed.

CLEAN-UP

Before GlueRemove™ dries; spills and tools can be cleaned up with water.
